Included is (1) a schedule granting authority for Lander to assess tuition and fees and the purpose of these fees (2) a revenue generation schedule by category as defined in the expenditure purpose section of the authority schedule and (3) the university's Board approved tuition and fees for the fiscal year ending June 30, 2019.

117.73. (GP: Fines and Fees Report) In order to promote accountability and transparency, each state agency must provide and release to the public via the agency's website, a report of all aggregate amounts of fines and fees that were charged and collected by that state agency in the prior fiscal year. The report shall include, but not be limited to: (1) the code section, regulation, or proviso that authorized the fines and fees to be charged, collected, or received; (2) the amount of the fine or fee; (3) the amount received by source; (4) the purpose for which the funds were expended by the agency; (5) the amount of funds transferred to the general fund, if applicable, and the authority by which the transfer took place; and (6) the amount of funds transferred to another entity, if applicable, and the authority by which the transfer took place, as well as the name of the entity to which the funds were transferred. The report must be posted online by September first. Additionally, the report must be delivered to the Chairman of the Senate Finance Committee and the Chairman of the House Ways and Means Committee by September first. Funds appropriated to and/or authorized for use by each state agency shall be used to accomplish this directive.

## **Lander University**

Proviso 117.73 - Fines and Fees

## **Authority**

Lander University derives its authority to assess various fines and fees in accordance with the South Carolina Code of Laws, Title 59, Chapters 101, 112 and 135 as well as provisos 117.7, 117.8 and 117.11 of the FY 2018-19 Appropriations Act. Title 34, Chapter 11 of the South Carolina Code of Laws authorizes a fine for returned checks.

## **Expenditure Purposes**

Categorized as follows

Tuition – Revenue used to support the instruction, research and public service mission of the University. Tuition is collected for the purpose supporting the program needs of the academic units which in turn provide regular course instruction to students. These unrestricted funds comprise the majority of revenue to the University's operating General Fund. Totals include Summer II, Fall, Spring and Summer I semesters. <a href="E&G">E&G</a> (Education & General) Course Amount represents that portion of the tuition directly related to providing course instruction to the students (see Academic below). <a href="Board required General Fees">Board required General Fees</a> are assessed to each enrolled student regardless of full time or part time status, as applicable, and represents that portion dedicated to covering expenses related to Student Activities, Technology, Athletics, Safety and Security, Transportation, Employment, Library as well as the Health and Wellness Centers. Tuition, presented in this report, is shown in the same manner as the university's audited financial statements (i.e., net of scholarship allowances).

Academic – Revenue derived from various fees assessed by the academic departments that cover expenses unique to instruction associated with that discipline including, but not limited to, supplies and materials, travel and insurance.

Other fines & fees – Revenues used to cover direct and indirect expenses associated with administrative processing of records and information. This category Includes deferment fees, matriculation fees, graduation fees and library fees and fines.

**Orientation** – Revenue used to cover direct and indirect expenses associated with freshmen orientation activities and events.

**Housing** – Revenue used to cover the various costs associated with housing including, but not limited to, salaries and fringe benefits, utilities, furniture, maintenance and repairs.

**Meal Plans** – Outsourced for the campus. Revenue is used to compensate the contractor for services rendered through contractual arrangements.

**Parking** – Revenue used to cover the cost of parking services.

Returned Checks - Revenue used to offset the cost of collections associated with accounts receivables.

## **Transfer of Fines and Fees Revenue**

No revenue derived from the University's various fines and fees were transferred to the General Fund of the State, nor to any other entity.

RETURN CHECK CHARGE - Charge for check returned by bank \$25

REFUND POLICY - No refunds or reduction of basic charges will be made due to a change in status (e.g. from full-time student to part-time student) after the last day to drop/add for the semester. No refunds will be made to part-time students for reduction of hours after the last day to drop/add for the semester. The date the student files written notice of withdrawal with the Registrar's Office is the date in determining refunds. Refunds will be determined according to the policy in the current catalog and will be processed within 30 days of date of withdrawal.

#### OTHER FEES AND EXPENSES\*

COURSE OVERLOAD FEE: Students enrolled in 19 hours or more will pay an additional \$150 per credit hour.

**EMERGENCY MANAGEMENT NON-RESIDENT FEE:** Non-resident students enrolled in Emergency Management Masters Degree Program will be assessed a \$150 fee each semester.

RE-REGISTRATION FEE: Students whose classes were canceled and want to re-register will be charged \$100.

FRESHMAN ORIENTATION FEE: Students attending orientation will be required to pay a \$120 fee that will be included as part of fall bills.

APPLIED MUSIC FEE: (10 - 12 hours of private instruction)

Students majoring or minoring in music and taking Applied Music will be charged an additional \$200 per semester for one hour applied lessons (MUSK, MUSN, MUSV:150, 151, 250, 251, 350, 351, 450, 451) plus normal fees.

Students majoring or minoring in music and taking Applied Music will be charged an additional \$100 per semester for 30 minute applied lessons (MUSK, MUSN, MUSV: 152, 153, 154, 155, 252, 253, 254, 255, 352, 353, 354, 355, 452, 453, 454, 455) plus normal fees.

INTERNATIONAL STUDENTS: All students classified as international students will be required to participate in the Lander University International Student Insurance Program. No exceptions will be made to this policy. International students are required to purchase mandatory student medical insurance offered through an outside company.

Student Athlete - \$1,566 Student Non-Athlete - \$885

A one-time matriculation fee of \$300 will be assessed for new and transferring international students.

**SENIOR CITIZENS:** Senior citizens may register for classes only *after* regular registration times on a space available basis at no cost.

**NURSING SPECIAL EXPENSES:** Special expenses for nursing students are approximately \$500. For more detail, see the Nursing Student Handbook available at
